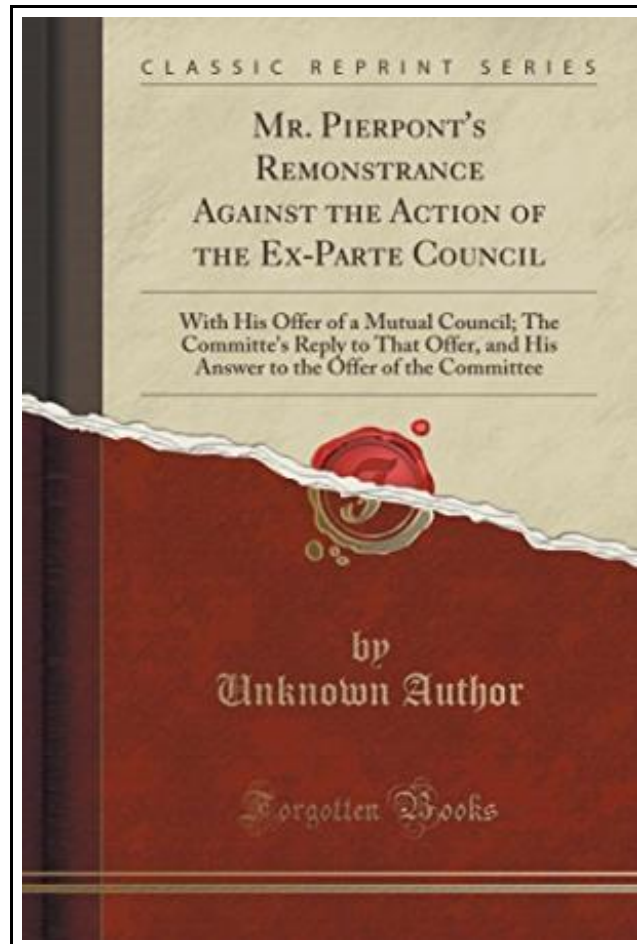

They are three. First: - A year ago, last October, at their meeting on the 7th of that month, I tendered to the Proprietors of Hollis Street Meeting House, a mutual Council, whose decision should be conclusive, final, and forever binding upon both parties, among other matters, upon these two points; namely, 1 st. Whether, by reason of any thing that I had done, or left undone, in relation to the Temperance cause, or any other cause, the connexion between the Society and myself ought to be dissolved; and 2dly, - if, for any cause whatever, the relation between the Society and myself ought to be dissolved, what were the terms and conditions on which that dissolution should take place. In this proposal, I trust that the body that I now address will see proof of a disposition, on my part, to put an end to strife, the strife, - then and now, existing between the Proprietors and myself.
